Overview

- Established by ACT No. 497 in the 2022 Regular Session, the Louisiana State Legislature authorized the Political Subdivision Federal Grant Assistance Fund (§100.192) "to assist political subdivisions with competitive federal grant opportunities made pursuant to the Infrastructure Investment and Jobs Act (P.L. 117-58)"
- As a result of this legislation, a collaborative partnership between LMA and PJAL established LITACorp, a new nonprofit organization, to administer these funds on behalf of DOA
- Beginning in 2023, LITACorp will administer technical assistance and a matching funds program specifically for local government entities located in rural and economically distressed areas



Goals

- Equip political subdivisions located in rural and economically distressed areas with the tools and resources they need to identify, apply for, and administer federal grants funded through the IIJA
- Minimize barriers for political subdivisions to access federal resources by assisting them with meeting local cost share requirements of federal grant programs funded through IIJA
- Acquire federal grant funds through the IIJA to construct, improve, or repair public infrastructure – water and sewer systems, roads, bridges, railways, ports, broadband, etc. – in rural and economically distressed communities throughout Louisiana



Infrastructure Investment & Jobs Act (IIJA)

- Also known as the Bipartisan Infrastructure Law (BIL)
- Provides \$1.2 trillion nationwide for infrastructure, including:
 - Utilities
 - Transportation
 - Broadband
 - Climate, Energy, and the Environment
- Contains 375 different funding programs
- Many are competitive grant opportunities open to the city/town and parish level



Programs

- Technical Assistance Program
- Matching Funds Grant Program



Technical Assistance Program

- LITACorp launched the Technical Assistance Program (TAP) in June 2023
- LITACorp's TA Team is supported by Franklin Associates, GrantWorks, and Hunt, Guillot & Associates
- TA services include, but are not be limited to, the following:
 - Project development/prioritization
 - Funding identification
 - Grant writing
 - Grant administration
- Interested communities must submit a Letter of Intent (LOI) to LITACorp to be considered for TA services

- ✓ Step 1: Letter of Interest Submitted
- ✓ Step 2: Eligibility Determination
- ✓ Step 3: Discovery Call with TA Team
- ✓ Step 4: Memorandum of Understanding
- ✓ Step 5: Needs Assessment
- **✓** Step 6: Strategic Priority Discussion
- ✓ Step 7: Grant Strategy
- ✓ Step 8: Grant Application
- ✓ Step 9: Grant Management

Matching Funds Grant Program

- LITACorp has developed a \$20 million Matching Funds Grant Program (MFGP)
- The MFGP assists local governments with meeting local cost share requirements established by grant programs funded through the IIJA
- To participate in the MFGP, eligible communities must submit an application to LITACorp to be considered for an award
- LITACorp will evaluate all applications based on the following criteria: Distress, Rurality, Fiscal Health, and Capacity
- Regional partnerships will be encouraged to ensure federal grant applications are more competitive



Grant Awards

- LITACorp intends to award construction grants between \$250,000 and \$750,000, and non-construction grants between \$50,000 and \$350,000
- LITACorp reserves the right to make awards outside of these budget ranges, especially for projects demonstrating substantial regional impact




