### **SETTLEMENT**

The following Settlement is hereby agreed to between Mo-Dad Utilities, L.L.C. ("Respondent") and the Department of Environmental Quality ("DEQ" or "the Department"), under authority granted by the Louisiana Environmental Quality Act, La. R.S. 30:2001, et seq. ("the Act").

Ι

Respondent is a limited liability company that owns and/or operates numerous wastewater treatment plants serving subdivisions in Ascension, Livingston, St. Helena, Tangipahoa, West Baton Rouge, and East Baton Rouge Parishes in Louisiana (each a "Facility" and collectively, "Facilities"). The names of the Facilities and their agency interest numbers are set forth in the attached Exhibit 1.

II

On December 20, 2012, the Department issued to Respondent a Consolidated Compliance Order & Notice of Potential Penalty, Enforcement No. WE-CN-11-00831 (Exhibit 2).

On January 16, 2015, the Department issued to Respondent a Consolidated Compliance

Order & Notice of Potential Penalty, Enforcement No. WE-CN-14-00412 (Exhibit 3).

On May 14, 2015, the Department issued to Respondent an Amended Consolidated Compliance Order & Notice of Potential Penalty, Enforcement No. WE-CN-14-00412A (Exhibit 4).

On November 20, 2015, the Department issued to Respondent an Amended Consolidated Compliance Order & Notice of Potential Penalty, Enforcement No. WE-CN-14-00412B (Exhibit 5).

On May 26, 2017, the Department issued to Respondent a Consolidated Compliance Order & Notice of Potential Penalty, Enforcement No. WE-CN-17-00409 (Exhibit 6).

III

In addition to the violations noted in the enforcement actions noted in the above exhibits, this Settlement shall resolve all of the Respondent's liability for penalties for all violations and noncompliance issues noted in Exhibit 7.

IV

Respondent denies it committed any violations or that it is liable for any fines, forfeitures. and/or penalties.

V

Anything contained in this Settlement Agreement to the contrary notwithstanding, this Settlement does not address any penalties for violations at the following facilities that were previously owned and operated by Respondent and for which Respondent is no longer responsible:

Nonetheless, Respondent, without making any admission of liability under state or federal statute or regulation, agrees to pay, and the Department agrees to accept, a payment in the amount of SIX HUNDRED THOUSAND AND NO/100 DOLLARS (\$600,000.00), of which Forty-Three Thousand Two Hundred Sixty-Five and 91/100 Dollars (\$43,265.91) represents the Department's enforcement costs, in settlement of the claims set forth in this agreement. The total amount of money expended by Respondent on cash payments to the Department as described above, shall be considered a civil penalty for tax purposes, as required by La. R.S. 30:2050.7(E)(1).

An initial payment of Four Hundred Thousand and No/100 Dollars (\$400,000.00) is to be made within ten (10) days from notice of the Secretary's signature. This initial settlement payment of \$400,000.00 shall be deemed payment for the Department's enforcement costs and any and all civil penalties settled pursuant to this agreement for the period beginning January 1, 2006 and ending June 30, 2015. Payment of the remaining Two Hundred Thousand and No/100 Dollars (\$200,000.00) shall be made in twenty-four (24) monthly installments. The first installment of \$8,333.41 shall be made by the 10th day of the month following the initial payment of \$400,000.00. The remaining twenty-three (23) installments of \$8,333.33 each shall be paid

monthly thereafter and each monthly installment payment shall be deemed a proportional payment for any and all civil penalties settled pursuant to this agreement for the period beginning July 1, 2015 and ending June 30, 2018. More specifically, the first monthly installment payment shall be deemed payment for 1.5 months of civil penalties addressing July 1, 2015 through August 15, 2015, the second monthly installment payment shall be deemed payment for 1.5 months of civil penalties addressing August 16, 2015 through September 30, 2015, and so on with such cycle/frequency continuing until payment is full has been made to the Department.

#### VII

Respondent further agrees that the Department may consider the inspection report(s), permit record(s), the Consolidated Compliance Orders & Notices of Potential Penalty, and this Settlement for the purpose of determining compliance history in connection with any future enforcement or permitting action by the Department against Respondent, and in any such action Respondent shall be estopped from objecting to the above-referenced documents being considered as proving the violations alleged herein for the sole purpose of determining Respondent's compliance history.

#### VIII

This agreement shall be considered a final order of the Secretary for all purposes, including, but not limited to, enforcement under La. R.S. 30:2025(G)(2), and Respondent hereby waives any right to administrative or judicial review of the terms of this agreement, except such review as may be required for interpretation of this agreement in any action by the Department to enforce this agreement.

This settlement is being made in the interest of settling the state's claims and avoiding for both parties the expense and effort involved in litigation or an adjudicatory hearing. In agreeing to the compromise and settlement, the Department considered the factors for issuing civil penalties set forth in La. R. S. 30:2025(E) of the Act.

X

As required by law, the Department has submitted this Settlement Agreement to the Louisiana Attorney General for approval or rejection. The Attorney General's concurrence is appended to this Settlement Agreement.

XI

The Respondent has caused a public notice advertisement to be placed in the official journals of the parish governing authorities in Ascension, Livingston, St. Helena, Tangipahoa, West Baton Rouge, and East Baton Rouge Parishes, Louisiana. The advertisement, in form and wording approved by the Department, announced the availability of this settlement for public view and comment and the opportunity for a public hearing. Respondent has submitted original proof-of-publication affidavits and original public notices to the Department and, as of the date this Settlement is executed on behalf of the Department, more than forty-five (45) days have elapsed since publication of the notices.

XII

Payment of \$400,000.00 is to be made within ten (10) days from notice of the Secretary's signature. If payment is not received within that time, this Agreement is voidable at the option of the Department. Payments are to be made by check, payable to the Department of Environmental Quality, and mailed or delivered to the attention of Accountant Administrator, Financial Services

Division, Department of Environmental Quality, Post Office Box 4303, Baton Rouge, Louisiana, 70821-4303. Each payment shall be accompanied by a completed Settlement Payment Form (Exhibit A).

#### XIII

In consideration of the above, any claims for penalties are hereby compromised and settled in accordance with the terms of this Settlement.

#### XIV

In addition to the violations noted in the enforcement actions noted in Paragraph II and the violations and noncompliance issues noted in Paragraph III, this Settlement shall resolve all of the Respondent's liabilities for penalties under the Louisiana Water Control Law, La. R.S. 30:2071, et seq., and the Louisiana Water Quality Regulations, LAC 33:IX, for all violations and noncompliance issues disclosed to the Department in writing or otherwise known to the Department encompassing the period beginning January 1, 2006 and ending June 30, 2018.

#### XV

Each undersigned representative of the parties certifies that he or she is fully authorized to execute this Settlement Agreement on behalf of his or her respective party, and to legally bind such party to its terms and conditions.
