SETTLEMENT AGREEMENT

The following Settlement Agreement is hereby agreed to between QEP Energy Company f/k/a Questar Exploration and Production Company and QEP Field Services Company (“Respondents”) and the Department of Environmental Quality (“DEQ” or “the Department”), under authority granted by the Louisiana Environmental Quality Act, La. R.S. 30:2001, et seq. (“the Act”).

I

Respondents are corporations that owned and/or operated facilities located in Bienville Parish, Bossier Parish, Caddo Parish, DeSoto Parish, Lincoln Parish, Red River Parish, Union Parish, and Webster Parish, Louisiana (“the Facilities”).

II

On July 13, 2010, the Department issued to Respondent a Notice of Potential Penalty, Enforcement Tracking No. AE-PP-09-0572 (Exhibit 1).

On February 17, 2011, the Department issued to Respondent a Notice of Potential Penalty, Enforcement Tracking No. AE-PP-10-01019 (Exhibit 2).

On September 12, 2011, the Department issued to Respondent a Notice of Potential Penalty, Enforcement Tracking No. AE-PP-10-01870 (Exhibit 3).

Additional violations, not cited in the foregoing enforcement actions, are included within the scope of this settlement (Exhibit 4).

### III

Respondents deny they committed any violations or that they are liable for any fines, forfeitures and/or penalties.

### IV

Nonetheless, Respondents, without making any admission of liability under state or federal statute or regulation, agrees to pay, and the Department agrees to accept, a payment in the amount of ONE HUNDRED FIFTY THOUSAND AND NO/100 DOLLARS (\$150,000.00), of which Two Thousand Two Hundred Thirty-Five and 02/100 Dollars (\$2,235.02) represents the Department's enforcement costs, in settlement of the claims set forth in this agreement. The total amount of money expended by Respondents on cash payments to the Department as described above, shall be considered a civil penalty for tax purposes, as required by La. R.S. 30:2050.7(E)(1).

### V

Respondents further agree that the Department may consider the permit record(s), the Notices of Potential Penalty and this Settlement Agreement for the purpose of determining compliance history in connection with any future enforcement or permitting action by the Department against Respondents, and in any such action Respondents shall be estopped from objecting to the above-referenced documents being considered as proving the violations alleged herein for the sole purpose of determining Respondents' compliance history.

VI

This agreement shall be considered a final order of the Secretary for all purposes, including, but not limited to, enforcement under La. R.S. 30:2025(G)(2), and Respondents hereby waive any right to administrative or judicial review of the terms of this agreement, except such review as may be required for interpretation of this agreement in any action by the Department to enforce this Settlement Agreement.

VII

This Settlement Agreement is being made in the interest of settling the state's claims and avoiding for both parties the expense and effort involved in litigation or an adjudicatory hearing. In agreeing to the compromise and settlement, the Department considered the factors for issuing civil penalties set forth in La. R. S. 30:2025(E) of the Act.

VIII

As required by law, the Department has submitted this Settlement Agreement to the Louisiana Attorney General for approval or rejection. The Attorney General's concurrence is appended to this Settlement Agreement.

IX

The Respondents have caused a public notice advertisement to be placed in the official journal of the parish governing authority in Bienville Parish, Bossier Parish, Caddo Parish, DeSoto Parish, Lincoln Parish, Red River Parish, Union Parish, and Webster Parish, Louisiana. The advertisement, in form and wording approved by the Department, announced the availability of this settlement for public view and comment and the opportunity for a public hearing. Respondents have submitted an original proof-of-publication affidavit and an original public notice to the Department and, as of the date this Settlement Agreement is executed on behalf of the Department, more than

forty-five (45) days have elapsed since publication of the notice.

X

Payment is to be made within ten (10) days from notice of the Secretary's signature. If payment is not received within that time, this Agreement is voidable at the option of the Department. Payments are to be made by check, payable to the Department of Environmental Quality, and mailed or delivered to the attention of Accountant Administrator, Financial Services Division, Department of Environmental Quality, Post Office Box 4303, Baton Rouge, Louisiana, 70821-4303. Each payment shall be accompanied by a completed Settlement Payment Form attached hereto.

XI

In consideration of the above, any claims for penalties are hereby compromised and settled in accordance with the terms of this Settlement Agreement.

XII

Each undersigned representative of the parties certifies that he or she is fully authorized to execute this Settlement Agreement on behalf of his or her respective party, and to legally bind such party to its terms and conditions.

On or about February 2, 2010, a file review of **WOODARDVILLE CENTRAL FACILITY**, an oil and gas production facility owned and/or operated by **QUESTAR EXPLORATION AND PRODUCTION COMPANY (RESPONDENT)**, was performed to determine the degree of compliance with the Louisiana Environmental Quality Act (the Act) and the Air Quality Regulations. The facility is located off of Louisiana Highway 783, five (5) miles south of Ringgold in Bienville Parish, Louisiana. The facility currently operates under Air Permit No. 0360-00628-03, issued on August 5, 2008.

While the investigation by the Louisiana Department of Environmental Quality (the Department) is not yet complete, the following violations were noted during the course of the file review:

- A. On or about June 26, 2008, the Department received a Form of Notification of Change of Ownership/Operator or Name Change (NOC-1 Form) from the Respondent. According to the form, ownership and operatorship of Woodardville Central Facility was transferred to the Respondent on or about March 3, 2008. The Respondent's failure to submit a complete NOC-1 Form to the Department within 45 days after the change of ownership/operator is a violation of LAC 33:I.1905.A and La. R.S. 30:2057(A)(2).

- B. The Respondent operated the facility prior to receiving authorization from the Department. Specifically, the Respondent assumed ownership and operatorship of the facility on March 3, 2008, and the facility's air permit was transferred on July 10, 2008. The operation, without prior authorization from the Department, between March 3, 2008, and July 10, 2008, is a violation of LAC 33:III.501.C.2 and La. R.S. 30:2057(A)(1) and 30:2057(A)(2).

Pursuant to La. R.S. 30:2050.3(B), you are hereby notified that the issuance of a penalty assessment is being considered for the violations described herein. Written comments may be filed regarding the violations and the contemplated penalty. If you elect to submit comments, it is requested that they be submitted within ten (10) days of receipt of this notice.

Prior to the issuance of any additional appropriate enforcement action, you may request a meeting with the Department to present any mitigating circumstances concerning the violations. If you would like to have such a meeting, please contact Kenzie Bozeman, Environmental Scientist, at (225) 219-3748 within ten (10) days of receipt of this **NOTICE OF POTENTIAL PENALTY**.

The Department is required by La. Include with your statement of monetary benefits the method(s) you utilized to arrive at the sum. If you assert that no monetary benefits have been gained, you are to fully justify this statement.

For each violation described herein, the Department reserves the right to seek civil penalties and the right to seek compliance with its rules and regulations in any manner allowed by law, and nothing herein shall be construed to preclude the right to seek such penalties and compliance.

On or about June 28, 2010, a file review of the **SAMPLE DEHYDRATION SITE-THORN LAKE FIELD (FACILITY)**, owned and/or operated by **QEP FIELD SERVICES COMPANY (RESPONDENT)**, was performed to determine the degree of compliance with the Louisiana Environmental Quality Act (the Act) and the Air Quality Regulations. The facility is located on Louisiana Hwy 1, 17.5 miles northwest of Coushatta in Red River Parish, Louisiana. The facility currently operates under Louisiana State Air Permit Number 2420-00127-00, which was issued on or about April 23, 2010.

While the investigation by the Louisiana Department of Environmental Quality (the Department) is not yet complete, the following violations were noted during the course of the file review:

- A. Construction of the facility began prior to October 7, 2008. The Respondent submitted an air permit application to the Department on or about February 1, 2010.
