The proposed rule change is not required by federal regulation. The proposed rule change provides clarification and better customer service, clarifies expectations, and provides these services more effectively and efficiently. The Permit Application and Administrative Review group (PAAR) within the Public Participation and Permit Support Division (PPPSD) is responsible for processing Notification of Change (NOC-1) Forms pursuant to LAC 33:I.Chapter 19. Due to the apparent lack of specificity in the current regulation, many applicants submit NOC-1 Forms that are incomplete or request action on activities not covered in the regulation, resulting in a high percentage of NOC-1 Forms requiring deficiency letters or additional clarification. For example, the PAAR group frequently receives NOC-1 Forms for activities not covered by the regulations or the group (examples include radiation and Underground Storage Tank facilities). PAAR also receives NOC-1 Forms for activities that are not transferable (examples include expired or terminated permits, air exemptions, and certain storm water general permits). Addressing these requests not only requires staff time, but it is also frustrating to the regulated community.
