Final Comment Summary Response & Concise Statement – Substantive Changes to Proposed Rule AQ348 Regulatory Permit for Storage Vessels LAC 33:III.321 Log Number AQ348S

COMMENT

1: LMOGA submitted comments on August 2, 2017, to the Department of Environmental Quality ("DEQ") requesting AQ348 consider clearly limiting the jurisdiction by expressly excluding exploration and production vessels. LMOGA provided recommended language. In addition, LMOGA proposed adding language to §321.B explicitly excluding produced water tanks.

Subsequently, the DEQ published a notice for a substantive rule change hearing in the potpourri section, AQ348S, of the Louisiana State Register on October 20, 2017, without making LMOGA's requested changes. Based on response to comments by the DEQ on AQ348 and the DEQ's decision not to include such language, LMOGA infers that the above rule shall only apply to downstream oil and gas, not activities related to the exploration and production.

No arguments necessary; comment does not suggest amendment or change.

RESPONSE

1: As noted in the Comment Summary Response & Concise Statement associated with AQ348, LDEQ concurs that the Regulatory Permit for Storage Vessels is not intended to address the Crude Petroleum and Natural Gas source category (SICC 1311). For example, the storage vessel standards under LAC 33:III.321.D do not address 40 CFR 60 Subparts OOOO or OOOOa or 40 CFR 63 Subpart HH. Instead, the Minor Source Air General Permit for Crude Oil and Natural Gas Production (commonly referred to as the MSOG) is LDEQ's preferred mechanism to streamline the permitting of such facilities.
