

I. Introduction

The Louisiana Department of Environmental Quality's (LDEQ) Intended Use Plan (IUP) for the Clean Water State Revolving Fund (CWSRF) is prepared in accordance with the provisions of Title VI of the Clean Water Act of 1987, and Bipartisan Infrastructure Law (BIL) signed by President Biden on November 15, 2021. This IUP is a required part of the process to request the Capitalization Grants for the Emerging Contaminants Grant. The FFY2022 grant allotment is \$1,028,000. This IUP describes LDEQ's intention to transfer the FFY2022 grant allotment to the Drinking Water Revolving Loan Fund (DWRLF.)

The CWSRF program was established pursuant to Title VI of the Clean Water Act, as amended in 1987 (the Act). The CWSRF program presently operates under R.S. 30:2301-2306 (Act 296 of the 2010 Regular Session of the Louisiana Legislature). These statutes establish a state revolving loan fund capitalized by federal grants (Capitalization Grants for Clean Water State Revolving Funds, CFDA 66.458), by state funds when required or available, and by any other funds generated by the operation of the clean water revolving loan fund. LDEQ is authorized to engage in activities regarding the sums on deposit in, credited to, or to be received by the state revolving loan fund. The Financial Services- Support Division and Water Planning and Assessment Division within LDEQ are responsible for the operations of the CWSRF program in the State of Louisiana. These divisions within LDEQ provide assistance to municipalities in developing, financing, and implementing wastewater treatment and/or storm water management plans. The Water Planning and Assessment Division provide engineering oversight, design review, and inspection services as well as environmental assessments. The Financial Services Division oversee grant management, program administration, and financial services on eligible projects. All efforts are directed toward improving water quality by assisting communities in providing wastewater treatment processes that meet established effluent limits and achieve the goals of the Clean Water Act.

II. Transfer of Funds from the Drinking Water Revolving Loan Fund

LDEQ reserves the authority to transfer additional funds as appropriate, at some time in the future, between the CWSRF and DWRLF program. Transfers eligible up to 33 percent of the FFY 2022 DWRLF capitalization grants are possible. LDEQ has solicited for projects and, even though there was initially some interest in projects for the Emerging Contaminants grant, none of those projects have come to fruition. To avoid sending the money back to EPA, LDEQ plans to transfer the full Emerging Contaminants FFY 2022 allotment of \$1,028,000 to the DWRLF in SFY2024. LDEQ does not expect any long impacts on the current year's fund, set asides, or in the long term. Since this allotment was never included in our payment or binding commitment schedules it won't affect them.

As Attorney General for the State of Louisiana (the "State"), and in connection with the Clean Water State Revolving Fund Program (the "SRF"), I have examined, or caused to have examined on my behalf, the Constitution and statutes and rules of the State and such other documents as I deemed necessary and appropriate in order to render this certification. Based upon this review and based upon the opinion of Special Counsel to the Louisiana Department of Environmental Quality ("LDEQ"), I hereby certify that:

- The State legislation establishing the SRF and the powers it confers are consistent with the 1. Louisiana Constitution and State law, and the State may legally bind itself to the terms of the capitalization grant agreement.
- 2. The LDEQ policies and requirements implementing the SRF are legally enforceable and binding on recipients of SRF assistance under the Constitution and laws of the State.
- 3. The State legislation establishing the SRF permits transfers between the SRF and Louisiana Department of Health's Drinking Water Revolving Loan Program.
